





### **Lacey Act Amendments Do Not Move Forward in Congress!**

A message from the National Aquaculture Association:

The CHIPS and Science bill signed by President Biden yesterday included the technology initiatives of the America COMPETES Act, USICA, and other bills. The portions of COMPETES not pertinent to the bill (including Section 71102, Lacey Act Amendments) were not included. This should be the end of any threat to US aquaculture posed by the ill-conceived Lacey Act amendments during the 117th Congress which ends January 3, 2023.

Thank you to everyone who contacted their Senators and Representative to express your opposition! Your informed outreach is hugely important when advocacy groups like the National Aquaculture Association, American Farm Bureau Federation, US Association of Reptile Keepers, Pet Advocacy Network and other like-minded organizations meet with legislators. Our message gains traction when Congress has been hearing from constituents.

Also, a huge thank you to the animal keepers and organizations who opposed the Lacey Act amendments! The NAA and US aquaculture were not the only ones fighting these provisions. Stopping the Lacey Act amendments demonstrates that various animal interest groups can work together, make a difference, and be effective against animal rights organizations that fought hard for the amendments.

# FDA Takes Significant Step Expanding Indexed Drugs Option to Broodstock

A significant step has been achieved to fully implement a provision within the Minor Use, Minor Species Act (MUMS Act) authorizing Indexed drugs. The U.S. Food and Drug Administration (FDA) has withdrawn guidance for industry (GFI) #210, *The Index of Legally Marketed Unapproved New Animal Drugs for Minor Species*.

This breakthrough was triggered by the National Aquaculture Association presenting to the agency an analysis demonstrating: 1) broodstock do not typically enter the food marketing chain and 2) regulations at the federal and state levels reinforce drug label restrictions preventing broodstock consumption as human food.

An incentive established by the 2004 MUMS Act was the Index of Legally Marketed Unapproved New Animal Drugs for Minor Species, also commonly referred to as “the Index.” The Index consists of a list of legally marketed unapproved new animal drugs for minor species that meet the requirements of section 572 of the Food, Drug and Cosmetics Act. Indexing represents a pathway for legally marketing unapproved new animal drugs.

As the agency drafts new guidance for industry, they are encouraging potential Indexing applicants to consult GFI #201, “[Small Entities Compliance Guide for Index of Legally Marketed Unapproved New Animal Drugs for Minor Species](#),” and consult with the agency’s [Office of Minor Use & Minor Species](#) (OMUMS). OMUMS will determine the eligibility of a drug for Indexing on a case-by-case basis.

Next up for the National Aquaculture Association is an effort to achieve FDA recognition that early life stages are eligible for Indexing.

The 2022 Census of Agriculture is right around the corner and USDA NASS is making every effort to count all aquaculture producers in the United States. If you produce any aquaculture products and want to make sure that you are counted in the 2022 Census of Agriculture and the 2023 Census of Aquaculture, please sign up your operation using this online form: <https://www.agcounts.usda.gov/cgi-bin/counts/>

Once you have signed up, you might receive a short survey in the next two years to further categorize your operation. But most likely, you will not receive a survey until the 2022 Census of Agriculture in January or February, 2023.

There is NO sharing of individual farm financial data with other federal agencies other than the final compiled reports that are publicly available.
